- Seller's Health Guarantee. Seller represents that it is the legal owner of the Dog and has full authority to sell the Dog. Seller further represents that the Dog is in good health at the time of this sale, and will provide a genetic health guarantee to Buyer for a period of one (1) year from the delivery of the Dog to Buyer, provided that: Buyer has the Dog examined by Buyer's veterinarian within three (3) days of the delivery and follows all recommendations of the veterinarian related to the care of the Dog. In the event that Buyer fails to have the Dog examined within the 3-day period, this guarantee is null and void. This guarantee is not transferable to any subsequent owner of the Dog. In the event that the Dog fails the examination, Buyer may return the Dog, with a written statement from the veterinarian, to Seller within five (5) days of the examination for a full refund. If Buyer chooses to keep the Dog, no replacement shall be given and all medical costs and treatment are the sole responsibility of Buyer, and this health guarantee will be null and void. In the event Buyer makes a claim under this guarantee that leads to a full refund of the Purchase Price, Seller may, at its option, require Buyer to return the Dog to Seller at Buyers expense.
- <u>Feeding Reccomendations.</u> Seller feeds adults and puppies quality PawTree Food, and also requires that new puppy families continue feeding PawTree food for the duration of the guarantee (1year).
- <u>Limitation of Damages</u>. Notwithstanding anything in this Bill of Sale to the contrary, Seller's liability for the breach of any representation, warranty, or term of this Bill of Sale shall be limited to the amount of the Purchase Price.
